



Fines, punishments, number of points and reconciliation order

According to the Law No. 52 for the year 2001 for decree regulations adjustment for the Law No. 67 for the year 1976 and also the ministerial decision No. 2001/1956 concerning the application of the point system in the traffic fines therefore, it is the police and traffic man duty to benefit from this schedule which clarifies the connection between the traffic fine, the punishment, number of points and reconciliation order.



Continuation to Article "33" reiterated, will be punished by an imprisonment not exceeding three months and a fine not exceeding 100 K.D. or either of the two punishments who commits the following:

- 1 exceed the maximum speed limit.
- 2 Organize cars race on the roads without permission.
- 3 Driving a vehicle on the opposite traffic direction on the highways and the ringroads.

The court orders withdrawing the driving license for not more than a year, & in case of returning to court, it may order to withdraw the driving license for not more than three years.
